The vouchers truly gave us some breathing room. It also really warmed our hearts to feel that someone sees and appreciates the service, the effort, and the sacrifice - not just mine, but my family's too..."

At the height of the second war with Iran, when life was especially chaotic and prices continued to climb, our support was invaluable. On behalf of the thousands of soldiers, spouses, children, parents and other family members impacted by your compassion, we thank you. We have asked the accounting firm Deloitte Israel to audit the program and ensure full transparency of the project, which took place from March 10-31, 2026. We have enclosed a copy of their report here.
